Peddler's Permit

If you do not have a business license, you will be required to purchase a Peddler's License for an additional \$25 (See attached application). Peddler's permits are valid for one year.

Setup

Early Set-up: Must pre-register by Thursday,

May 2, by calling

Day-of Set-up: Begins at 6 am on the day of the event (5/14). All booths must be setup

and ready no later than 9:30 am.

Breakdown

Exhibitors may begin breaking down their booths at the conclusion of the event. All booths must be packed up no later than 5 pm.

Parking

Limited parking is available along Sunset Ave. We would like to keep the main lot available for event attendees.
